**Subject: individual exemption from mandatory participation in accordance with Section 97 subsection 2 of the Dutch Pension Act (*Pensioenwet*)**

Dear Madam, Sir,

You wish to be eligible for individual exemption from participation in the mandatory pension scheme of Bpf Koopvaardij pursuant to Section 97 subsection 2 of the Dutch Pension Act (*Pensioenwet*).

This letter is to inform you about the possibility for seconded sailors, living in other EU Member States or States belonging to the European Economic Area, to be exempted on request from mandatory participation in the pension scheme of Bpf Koopvaardij if they already participate in a supplementary pension insurance scheme in their country of residence. Until recently the possibility of individual exemption provided for in the Dutch Pension Act could not be implemented because sailors always had to be employed by a Dutch maritime employer. Because of the implementation of the new ILO's Maritime Labour Convention (MLC2006) this requirement has been cancelled. That is why a different form of employership such as cross-border secondment has become formally possible. The respective amendment to the Act was accepted by the Senate on 5 July 2011. The possibility of individual exemption has been provided for in Section 97 subsection 2 of the Dutch Pension Act.

The respective Section makes it possible to grant individual exemptions from participation in the mandatory (supplementary) pension scheme of the BPF Koopvaardij on request to employees from other EU Member States or States belonging to the European Economic Area. You must then be seconded and/or paid by a company established in your country of residence. Another condition is that you must have already joined a supplementary pension scheme in your country of residence and that the contributions are continued to be paid into this scheme during the secondment and/or employment.

Exemptions in connection with Section 97 subsection 2 of the Dutch Pension Act must be considered within the sense of a statutory exemption from mandatory participation. The requirements include for instance: the existence of a Secondment Certificate (A1 Statement, formerly Form E101) and the evidence of your participation in a supplementary pension scheme in your country of residence. Even if you are not seconded but you are working under another form of employment pursuant to the application of Article 11 paragraph 4 of the EU Regulation 883/2004, you must submit an A1 Statement.

This EU Statement entails in short that a company in the country of residence can be regarded as the employer for social security purposes if this company pays the wage.

The A1 Statement certifies that the company in your country of residence has registered you as an insured person with the social insurance body in your country of residence.

Before you decide to submit an application for exemption we recommend that you read the [Pension Scheme](#) properly. You can find the Pension Scheme at [uk.bpfkoopvaardij.nl/downloads](http://uk.bpfkoopvaardij.nl/downloads). It explains the pension scheme of the Dutch Merchant Navy and on the basis of examples you can make an estimate of the entitlements you can build up if you participate. One aspect of the scheme to which we particularly want to draw your attention is the entitlement to dependants' pension. In the unlikely event that you die during your participation in the pension scheme, your dependants (partner and children) will be entitled to a dependant's pension based on what you would have built up right up to the retirement age of 67 years. So please always involve your partner in your decision. You and your employer each pay half the contribution. In the event of an exemption you also lose your entitlement to your employer's contribution.

What you have to do in order to become eligible for an exemption from the mandatory supplementary pension scheme of the Fund:

- Apply for a Secondment Certificate (A1 Statement) from the social insurance body in your country of residence; this also applies if you are not seconded but you are paid by a company in your country of residence;
- Send the evidence of adequate supplementary pension insurance already taken out in your country of residence including evidence of recent contribution payments;
- Complete and sign the application form.

You can apply for the Secondment Certificate (A1 Statement) from (complete details of the respective country).

After having received the documents referred to above, assessment will take place with regard to whether you are eligible for an exemption.


As soon as the application has been assessed you and the vessel manager will be informed of the decision by the Board of Bpf Koopvaardij. If an exemption is granted, from that time onwards no contribution will be owed any longer to Bpf Koopvaardij.

The Fund will periodically review whether the requirements for exemption are still met. If it appears that you no longer meet the conditions, from that moment onwards the participation or as the case may be contribution payments to the Fund will become mandatory again. You and the vessel manager will be informed of this by the Fund.
